6. The Purchaser in consideration of the DJ Service to be rendered by the DJ, and the mutual promises contained herein, hereby agrees to pay to the DJ the following consideration:

A non-refundable reservation fee of \$50, is required to secure the services of Electric Circuit DJ Service for the engagement. This amount shall be applied toward the Performance Fee.

Additional Terms and Conditions

The agreement of the DJ to perform is subject to proven detention by accidents, riots, strikes, epidemics, acts of God, or any other legitimate conditions beyond their control. If such circumstances arise, all reasonable efforts will be made By Electric Circuit DJ Service to find replacement entertainment at the agreed upon fees. Should Electric Circuit DJ Service be unable to procure a replacement, Purchaser shall receive a full refund. Purchaser agrees that in all circumstances, Electric Circuit DJ Service liability shall be exclusively limited to an amount equal to the performance fee and that Electric Circuit DJ Service shall not be liable for indirect or consequential damages arising from any breach of contract.

All deposits are nonrefundable if cancelled within 30 days of the engagement unless the DJ cancels the engagement.

No performance on the engagement shall be recorded, reproduced, or transmitted from the place of performance, in any manner, or any means whatsoever, in the absence of a specific written agreement with Electric Circuit DJ Service relating to and permitting such recording, reproduction, or transmission. Pictures and videotape of the event are permitted for the private use of the contracting party only.

The purchaser and DJ agree that this contract is not subject to cancellation unless both parties have agreed to such cancellation in writing. In the event the Purchaser breaches the contract, he or she shall pay the DJ the amount set forth above as "Wage agreed upon" as liquidated damages.

If the purchaser and/or guests of the purchaser deliberately or accidentally cause damages to Electric Circuit DJ Services equipment, the Purchaser hereby acknowledges that they will be required to provide financial compensation to replace or restore damaged equipment provided by Electric Circuit DJ Services.

It is understood that if this is a "Rain or Shine" event, Electric Circuit DJ Service compensation is in no way affected by inclement weather. The DJ reserves the right, in good faith, to stop or cancel the performance should the weather pose a potential danger to him, the equipment, or audience. Every effort will be made to continue the performance. However, safety is paramount in all decisions. The DJ's compensation will not be affected by such cancellation.

In the event of circumstances deemed to present a threat or implied threat of injury or harm to Electric Circuit DJ Service staff or any equipment in Electric Circuit DJ Service possession, Electric Circuit DJ Service reserves the right to cease performance. If the Purchaser is able to resolve the threatening situation in a reasonable amount of time (maximum of 15 minutes), Electric Circuit DJ Service shall resume performance in accordance with the original terms of this agreement. Purchaser shall be responsible for payment in full, regardless of whether the situation is resolved or whether Electric Circuit DJ Service resumes performance. In order to prevent equipment damage or liability arising from accidental injury to any individual attending this performance, Electric Circuit DJ Service reserves the right to deny any guest access to the sound system, music recordings, or other equipment.

Purchaser Initials _	-	Electric Circuit DJ Service:	

Purchaser shall provide Electric Circuit DJ Service with safe and appropriate working conditions. This includes a 6-foot by 6-foot area for setup, space for setting up speakers and lighting stands. Electric Circuit DJ Service requires a minimum of one 15-20-amp circuit outlet from a reliable power source within 50 feet (along the wall) of the set-up area. This circuit must be free of all other connected loads. Any delay in the performance or damage to DJ's equipment due to improper power is the responsibility of the purchaser. Two circuits are preferred, where possible. Additional outlets on SEPARATE circuits for lighting (if contracted for) are required. Purchaser shall provide crowd control if warranted; and furnishing directions to place of engagement. Purchaser is responsible for paying any charges imposed by the venue. These charges may include, but are not limited to, parking, use of electric power, and fire marshal if necessary (for use of fog).

The Purchaser shall at all times have complete control, direction and supervision of the performance of Electric Circuit DJ Service at this engagement and Purchaser expressly reserves the right to control the manner, means and details of the performance of the services of Electric Circuit DJ Service. A written event/music planner or music request list must be received from the Purchaser and forwarded to Electric Circuit DJ Service at least two weeks prior to the date of the engagement for it to be included in Electric Circuit DJ Service programming guidelines. With or without the aid of an event/music planner or music request list, Electric Circuit DJ Service shall attempt to play Purchaser's and Purchaser's guests' music requests but shall not be held responsible if certain selections are unavailable. Electric Circuit DJ Service will make an extra effort to have music requests available if they are received IN WRITING at least two weeks prior to the engagement.

In the event of non-payment, Electric Circuit DJ Service retains the right to attempt collection through the courts. Purchaser will be held responsible for all court fees, legal fees, and collection costs incurred by Electric Circuit DJ Service. Purchaser shall be charged \$25 for each bounced check plus a \$7.50 service charge for each collection notice.

This agreement guarantees that Electric Circuit DJ Service will be ready to perform at the start time of the engagement. No guarantee is made as to Electric Circuit DJ Service time of arrival; however, Electric Circuit DJ Service requests that they be permitted 60 minutes before the engagement and 30 minutes after the engagement for setup and takedown. Electric Circuit DJ Service also requests ramp or elevator access between the parking/service entrance and the setup area.

Engagements within Chatham-Kent will not be assessed a travel charge. Services requiring travel outside of this area will be charged at \$50. Engagements in excess of 250 kilometers will require accommodations be made for an overnight stay in a local hotel/motel for Electric Circuit DJ Service to be provided by Purchaser.

Purchaser agrees to pay contract amount in full by cheque at time of consultation, or cash the event night before the DJ's begin unless otherwise specified.

By executing this contract as Purchaser, the person executing said contract, either individually, or as an agent or representative, represents and warrants that he or she is eighteen (18) years of age, and further, if executing said contract as agent or representative, that he or she has the authority to enter into this agreement and should he or she not have such authority, he or she personally accepts and assumes full responsibility and liability under the terms of this contract.

All attached riders are an integral part of this contract. This contract will supersede any other contract. If any part of this contract is illegal or unenforceable, the remaining provisions of this contract will remain valid and enforceable to both parties. This contract contains the entire agreement between the parties and no statement, promises, or inducements made by any party hereto, or agent or representative or either party hereto, which are not contained in this written contract, shall be valid or binding. This contract shall not be enlarged, modified, or altered except in writing by both parties and endorsed hereon.

The laws of the Province of Ontario shall govern this agreement. In the event of suit involving or relating to this agreement, Purchaser agrees that venue will be in Chatham - Kent.

Purchaser agrees to defend, indemnify, assume liability for and hold Electric Circuit DJ Service harmless from any claims, damages, losses and expenses by or to any person, regardless of the basis, which pertains directly or indirectly to Electric Circuit DJ Service performance. In the event that a civil action arises in an effort to enforce any provision of this agreement, the losing party shall pay the attorney's fee and court costs of the prevailing party.

Purchaser may not transfer this contract to another party without the prior written consent of

Electric Circuit DJ Service. This agreement is not binding until signed by both Purchaser and Electric Circuit DJ Service has received it. Any changes must be written and signed by both the Purchaser and Electric Circuit DJ Service. Oral agreements are non-binding. If any clause in this agreement is found to be illegal, the rest of the agreement shall remain in force.

Electric Circuit DJ Service may elect not to exercise their rights as specified in this agreement. By doing so, Electric Circuit DJ Service does not waive their right to exercise those options at a future date.

THE PARTIES hereto promise to abide by the terms of this agreement and intend to be legally bound thereby
